19MN04026 – Vandalism

On Sunday February 17, 2019, at approximately 10:40pm, patrols responded to Country Lane in Manalapan Township and met with the victim, a 23-year-old, East Brunswick, NJ resident. The victim's vehicle was parked on Country Lane in Manalapan Township on February 17, 2019. Sometime between 6:00pm and 10:30pm on February 17, 2019, an unknown subject threw two rocks through the rear of the victim's vehicle, causing the rear window and front windshield to break.
