20MN12661- Theft

On Tuesday, July 14, 2020, at approximately 1:25pm, patrols responded to a department store located on State Highway 9 in Manalapan in reference to a report of Theft. Further investigation revealed an adult female Aberdeen, NJ resident was observed by store security leaving the store without paying for merchandise. The subject then fled the scene and was later stopped by the Marlboro Police Department. The merchandise was recovered and returned to the department store.
