

Manalapan Twp. Police: Press Release / Police Blotter June 16th Through June 30th 2020

20MN11703 - Motor Vehicle Burglary

On Tuesday, June 30, 2020, at approximately 9:17pm, patrols responded to a residence located on Crystal Court for the report of an incident of Burglary. The victim, a 53-year-old Manalapan resident advised that sometime during the overnight hours between June 29, 2020 and June 30, 2020, an unknown actor(s) entered the victim's vehicle and removed a wallet. The wallet was later located near the residence and returned to the victim. This case is pending further investigation. Patrolman Philip Accatatta handled the report.
