Incident 20MN05890 - Fraud

On Tuesday, March 10, 2020, at approximately 3:40pm, the victim, a 72-year-old Manalapan, NJ resident responded to Manalapan Township Police Headquarters and reported an incident of Fraud. The victim advised that on March 9, 2020, an unknown actor(s) utilized the victim's bank account information by fraudulently depositing forged checks from a cell phone. Patrolman Jeremy Slad is the investigating officer.
