20MN06635 - Fraud

On Monday March 23, 2020 at approximately 9:00pm, the victim, a 67-year-old Manalapan, NJ resident reported her bank account was fraudulently accessed and a withdrawal was made. Patrolman Aaron Abeles handled the report.
