### **Incident 20MN07935- Burglary/ Theft**

On Tuesday, April 21, 2020, at approximately 5:21pm, the victim, a 29-year-old Manalapan, NJ resident reported an incident of Theft. The victim advised that sometime during the overnight hours of April 20, 2020, an unknown actor(s) entered his unlocked work truck while it was parked on the street in front of his residence and removed his wallet containing a NJ drivers License, cash and various credit cards.
