

### **18MN22151 – Warrant Arrest**

On Saturday, August 25, 2018, at approximately 5:00 p.m., Patrolman Kyle Williams conducted a motor vehicle stop in the parking lot of the Manalapan Epicenter located at the intersection of Route 9 South and Symmes Drive for a traffic violation. The driver of the vehicle, identified as Anthony L. Evans, a 53-year-old, unmarried, male, resident of Barnegat, NJ, who is employed as a house keeper, was found to have a warrant issued for his arrest by the Brick Township Municipal Court in the amount of \$500.00. Mr. Evans was placed under arrest and transported to Manalapan Township Police Headquarters where he was processed and released on his own recognizance.
