

# Manalapan Twp. Police: Press Release / Police Blotter NOVEMBER 13<sup>th</sup> Through NOVEMBER 26<sup>th</sup> 2019

#### Incident 19MN28797 - Criminal Mischief

On Monday, November 25, 2019, at approximately 6:14pm, patrols responded to a residence on Wintergreen Drive in reference to a report of criminal mischief. The victim, a 22-year-old Plainsboro, NJ resident, reported that her vehicle was keyed sometime during the previous night while it was parked in a driveway on Wintergreen Drive.
