

### **18MN06009 – Harassment**

On Sunday, March 4, 2018, at approximately 1:42 pm, patrols responded to the area of Cornell Place in reference to a report of a traffic complaint. The complaint involved vehicles and motorcycles traveling at high rates of speed down the road. After speaking with the complainant, patrols then responded to the suspect's residence. The suspect advised patrols that the complainant had intimidated them by coming onto their property and advising them to cease their reckless behavior.
