

### **18MN180084 – Fight / Simple Assault**

On Saturday, July 7, 2018, at approximately 11:58 p.m., Ptl. Matthew Mattia and Ptl. Dennis O'Brien responded to Marianne Manor; 327 Rt. 33 for a report of a fight in progress.
