

### **18MN16116 – Theft / Fraud**

On Thursday June 14, 2018 at 8:15 pm, a 59-year-old Manalapan resident responded to Manalapan Township Police headquarters in reference to a fraud incident that later was found to be a theft. Unknown subject(s) purchased products through Homedepot.com and shipped the products to the victim's home without having knowledge of the activity. Two males in FedEx uniforms were seen on the exterior surveillance camera's the homeowner has affixed to his home removing the packages from the front steps. The subjects do not appear to be FedEx employees. If anyone has information pertaining to this investigation, they are encouraged to contact the Manalapan Township Police Department.
