

17MN29676 - Theft

On Sunday, November 19, 2017 at 11:48 am, a 54-year-old resident of East Windsor, NJ, reported that his construction dump trailer valued at \$11,000.00 was removed from a residential property on Smithburg Road. The trailer contained half a ton of three quarter inch blue stone valued at \$100.00.
