

17MN25622 - Criminal Mischief

On Sunday, October 8, 2017 at 8:19 pm, I responded to a Georgetown Dr. address for a report of criminal mischief. The victim, a 22-year-old female from Manalapan, related that she turned left off of Old Queens Boulevard onto Gordon's Corner Road when a passing vehicle, possibly a dark colored Jeep Compass, possibly threw something at her vehicle.
