#### 19MN21987- Warrant Arrest

On Tuesday, September 3, 2019, at 12:59pm, John Marques, a 59-year-old male, married, self employed and resident of Linden, NJ turned himself in at Manalapan Township Police Headquarters regarding a warrant that was issued for his arrest from the Manalapan Township Municipal Court in the amount of \$1,000.00.
