

# Manalapan Twp. Police: Press Release / Police Blotter August 13<sup>th</sup> Through August 20<sup>th</sup> 2019

#### 19MN20892 - Warrant Arrest

On Tuesday, August 20, 2019, at approximately 2:15pm, patrols responded to the Monmouth County Probation Office and took custody of Jiterrah Oneal, a 26-year-old male, single, unemployed and resident of Ocean Township, NJ. Mr. Oneal had two warrants that were issued for his arrest by the Manalapan Township Municipal Court totaling \$1,361.00. Mr. Oneal was processed and transported to the Monmouth County Correctional Institution in default of bail. Patrolman James Joiner was the arresting officer.
