### 19MN10420 - Warrant Arrest

On Monday, April 29, 2019, at approximately 7:41am, Isiah Adams, a 27-year-old male, single, employed as a salesman and resident of Philadelphia, PA, responded to Manalapan Township Police Headquarters regarding a warrant that was issued for his arrest by the Manalapan Township Municipal Court in the amount of \$1000.00. Mr. Adams was processed and released after posting bail. Patrolman Anthony Cascella was the arresting officer.

#### 19MN10440- Fraud

On Monday, April 29, 2019, at approximately 11:16am, the victim, a 79-year-old Manalapan, NJ resident from Citation Lane responded to Manalapan Township Police Headquarters and reported an incident of Fraud. The victim advised that on April 20, 2019, an unknown actor utilized their bank debit card to complete fraudulent purchases on the internet totaling \$1,122.76.
