## 19MN13189 – Warrant Arrest

On Monday, May 27, 2019, at approximately 8:11am, patrols responded to the East Windsor Police Department and took custody of Kevin Pascal, a 49-year-old male, single, unemployed and resident of Princeton Junction, NJ. Mr. Pascal was found to have a warrant that was issued for his arrest by the Manalapan Township Municipal Court in the amount of \$1000.00.
