

# Manalapan Twp. Police 2019 PRESS RELEASE POLICE BLOTTER May 6 thorugh May 13 2019

19MN11999 – Possession of CDS, Possession of a Hypodermic Needle, Possession of Marijuana Less than 50 Grams, Possession of Drug Paraphernalia

On Monday, May 13, 2019, at approximately 8:36pm, patrols responded to the area of Oxford Road in reference to the report of a suspicious vehicle. The two occupants of the vehicle were identified as Alex Burhutin, a 24-year-old male, single, employed as a gas attendant and resident of Manalapan, NJ and Richard Kubynin, a 25-year-old male, single, employed as an optician and resident of Manalapan, NJ. Further investigation revealed that Mr. Burhutin was in possession of a controlled dangerous substance and a hypodermic needle.
