



## **Manalapan Twp. Police : Press Release / Police Blotter August 6<sup>th</sup> through August 13<sup>th</sup> 2019**

### **19MN20278 – Fraud**

On Tuesday, August 13, 2019, at approximately 7:54pm, the victim, a 55-year-old Manalapan, NJ resident from Country Oaks Drive, responded to Manalapan Township Police Headquarters and reported an incident of Fraud. The victim advised that on August 13, 2019, the victim's cell phone account was hacked and an unauthorized purchase was made for three new cell phones. The incident was handled by Patrolman Scott Rindsberg and is pending further investigation.

### **19MN20271- Theft**

On Tuesday, August 13, 2019, at approximately 5:11pm, patrols responded to a business located on State Highway 9 in reference to the report of a Theft.
