# ITEM of NOTE:

On Tuesday 07/02/2019 after a two day Active Shooter Response Competition held at the Howell Township Police Training Facility where several Law Enforcement Agencies throughout Monmouth County competed in firearms, tactical force on force competition and scenario based competitions the Manalapan Township Police Department Team comprised of Patrolmen Eric Voorand, Adam Sosnowski, Jason Vigneault, and Phil Accatatta emerged victorious; winning the competition.

# 19MN15843 - Fraud

On Tuesday, June 25, 2019, at approximately 7:54pm, the victim, a 36-year-old Manalapan, NJ resident from Champions Way responded to Manalapan Township Police headquarters and reported an incident of Fraud. Please note that no government agency would ask for payment of fines or otherwise through gift cards and not over the phone.
