20MN01171- Fraud

On Tuesday, January 14, 2020 at approximately 2:51pm, the victim, a 55 year-old Manalapan, NJ resident responded to Manalapan Township Police Department Headquarters and reported an incident of Fraud.

The victim advised that on January 3, 2020 an unknown actor(s) opened a cellular phone account in the victim's name, without permission, and purchased an electronic device valued at \$1,299.99. This incident is pending further investigation. Patrolman Peter Bylsma handled the report.

20MN01112 – Possession of Controlled Dangerous Substance/Intent to Distribute/Possession of Drug Paraphernalia Arrest
