

Manalapan Twp. Police 2019 PRESS Release Document April 1st thorugh April 8th

19MN08352 - Warrant Arrest

On Monday, April 8, 2019, at approximately 10:00am, the New Jersey State Police turned over Elmer J. Boyce, a 37-year-old male, married, laborer and a resident of East Stroudsburg, PA. Mr. Boyce had a warrant that was issued for his arrest by the Manalapan Township Municipal Court in the amount of \$1,000.00. Mr. Boyce was processed and remanded to the Monmouth County Correctional Institute in default of bail. Patrolman Anthony Cascella was the arresting officer.
