

Manalapan Twp. Police 2019 PRESS Release Document <u>April 9st thorugh April 15th</u>

19MN09117 – Shoplifting

On Sunday, April 14, 2019 at approximately 11:55 PM, an unknown black female reached into an unsecured cabinet below a closed check-out register and stole 2 packs of Newport Cigarettes, valued at \$17.24. The female was assisted by an unknown white male that blocked the view of a store employee at an adjacent register, as the female grabbed the cigarettes. The two suspects then fled the Woodward Road store in a black Honda Civic. The theft was captured on in-store security cameras and is under investigation to identify the suspects for criminal charges. Ptl Dennis O'Brien handled the report and the initial investigation.

19MN09109- Harassment

On Monday, April 15, 2019 between approximately 4:50pm and 5:00pm, a 55 year old Manalapan resident answered her cellular phone Face Time call from an unknown number and observed a nude male who she could not identify. Ptl. Christopher Makwinski handled the initial investigation report.

On Monday April 15th 2019 at approximately 12:00pm, a 50-year-old Manalapan resident advised he was defrauded out of \$200,001.00. The victim related he sent money to a subject who was claiming to be from a bank. This case is currently being investigated. Ptl. Kyle Earley took the report.
