POLICE BLOTTER January 15th to 21st 2020

20MN01739- Terroristic Threats

On Tuesday, January 21, 2010 at 2:26pm, patrols responded to a business located on State Highway 33, Manalapan, NJ in reference to a report of a subject that threatened employees. The victim's, a 59-year-old Manalapan, NJ resident and a 67-year-old Manalapan resident reported that a subject later identified through investigation had made threatening comments towards them over the telephone. Both victim's did not wish to pursue complaints at this time. Patrolman Joseph DeFilippis handled the report.
