

# Manalapan Twp. Police Department Press Release / Police Blotter May 20<sup>th</sup> through June 2<sup>nd</sup> 2020

## 20MN09918- Fraud

On Tuesday, June 2, 2020, at approximately 8:44pm, the victim, a 30-year-old California resident reported an incident of Fraud. The victim advised that on May 29, 2020. a Manalapan resident defrauded him by accepting payment for items that were never sent. Patrolman Jeremy Slad handled the report.
