21MN06498 – Fraud

On Tuesday, April 13, 2021, at 2:00 p.m., a 68-year-old Manalapan resident reported that an unknown actor(s) used the victim's information to make an unemployment claim in another state. No monetary loss was reported as a result of this incident. Patrolman Morgan Joiner handled the report.
