**22MN13994 – Harassment**

On Tuesday, June 21, 2022, at approximately 4:00 p.m., a 46-year-old Marlboro resident reported being harassed by a 36-year-old Freehold resident via text message. No complaints were signed as a result of this incident. Patrolman Christopher Schou handled the report.

**22MN13682 – Criminal Attempt (Burglary to a Motor Vehicle)**

On Sunday, June 19, 2022, at approximately 5:15 p.m., a 58-year-old Manalapan resident reported that an unknown actor, described as a black male wearing dark clothing and a ski mask, attempted to burglarize a vehicle that was parked in the driveway of a Thompson Grove residence.
