**Incident 22MN05136 – Criminal Mischief**

On Tuesday, March 15, 2022, at approximately 1:52 p.m., a 32-year-old Manalapan resident reported that an unknown actor punctured the tires of a vehicle sometime between March 11, 2022 and March 14, 2022 while it was parked at a Woodward Road address. The total cost of the damage was approximately \$4,200.00. Patrolman Bart Mattaliano took the report, which is pending further investigation.
