**25MN14327- Criminal Attempt**

On Tuesday, April 29<sup>th</sup>, 2025 at approximately 2:30 p.m., a 74-year-old Manalapan resident reported that an unknown actor, impersonating a Sheriff's Officer, attempted to scam them via telephone and email. The unknown actor attempted to convince the victim they had a warrant for their arrest and needed to pay them money. Patrolman Peter Pagano handled the initial report.
