**25MN03351 – Warrant Arrest / Hindering Apprehension / Possession of Controlled Dangerous Substances & Drug Paraphernalia**

On Wednesday, January 28, 2025, at approximately 7:15 p.m., Patrolman Kyle Williams and Patrolman Donovan Turner conducted a motor vehicle stop on Gordons Corner Road for motor vehicle violations. The driver, identified as Christopher Dimino, a 36-year-old, unmarried, male resident of Manalapan, who is employed as a delivery driver, was found to be in possession of a controlled dangerous substance and drug paraphernalia.
