### **POLICE BLOTTER** **February 26<sup>th</sup> to March 3<sup>rd</sup> 2020**

#### **19MN01569 / 20MN03433 – Burglary/Criminal Mischief/Theft of Property**

On February 11, 2020 at approximately 3:15pm, patrols responded to Colts Neck Police Department in reference to a suspect who was arrested by Colts Neck Police Department for a Burglary offense. It was determined that the suspect was linked to a separate burglary offense that was committed in Manalapan Township on January 19, 2020. Anthony Scifo, a 29-year-old male, single, unemployed and resident of Manalapan, NJ was taken into custody and charged with Burglary to a Dwelling, Criminal Mischief and Theft of Property.
