### **POLICE BLOTTER** **February 12<sup>th</sup> to 18<sup>th</sup> 2020**

#### **20MN04010 – Warrant Arrest**

On Sunday, February 18, 2020, at approximately 9:34am, Patrolman Christopher Oleksy conducted a motor vehicle stop on Craig Road for a motor vehicle violation. The driver, Osmaylin A.
